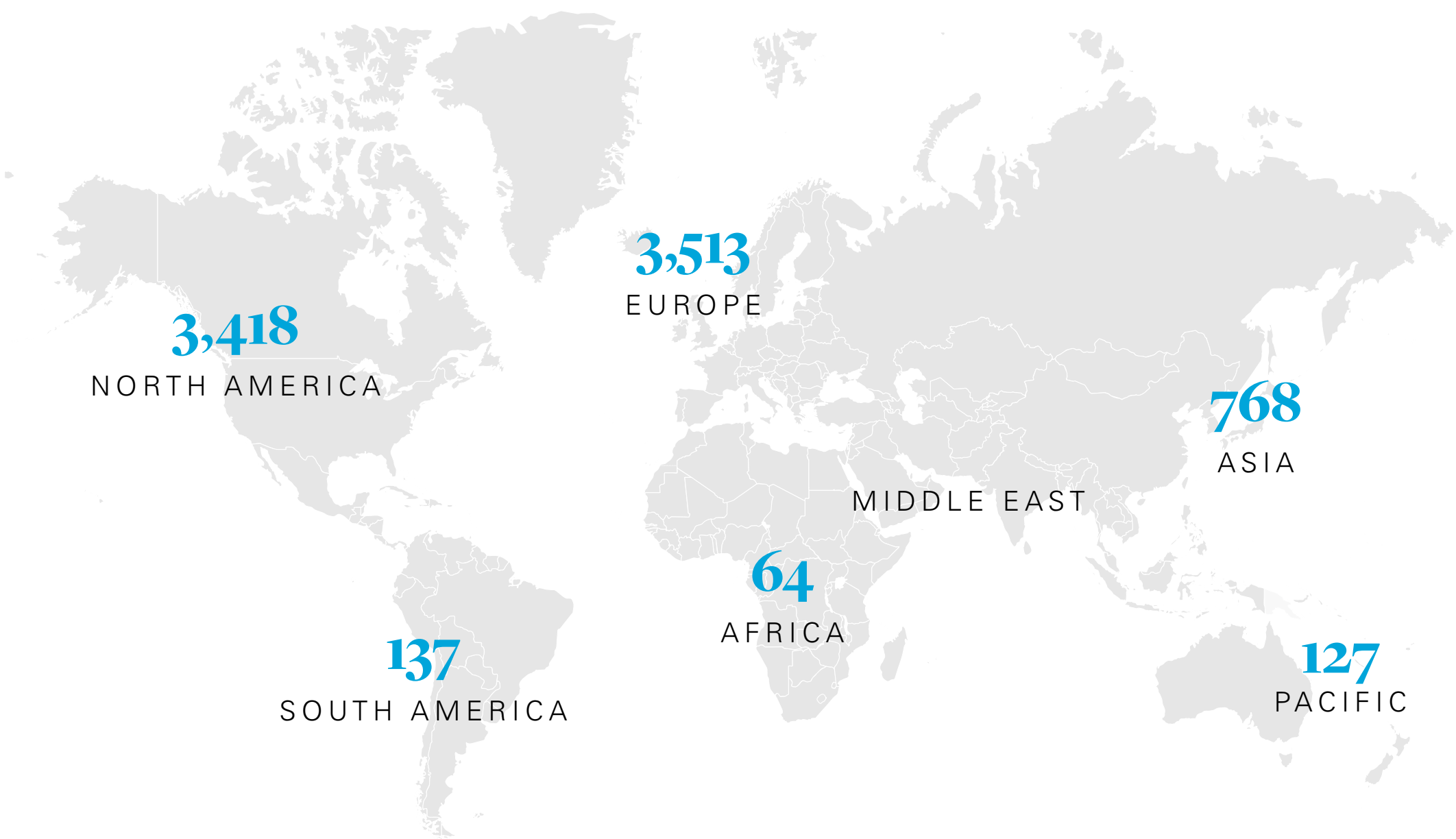

We hope you will stay connected once you leave the Firm.

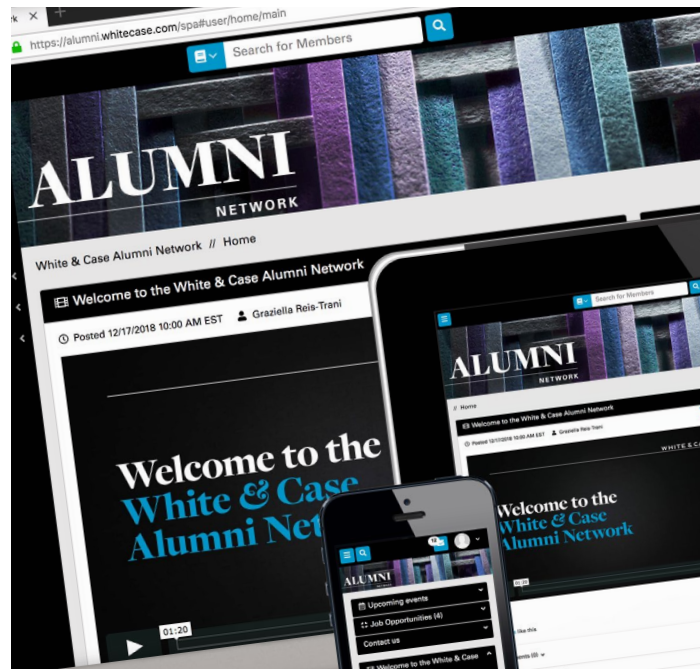

We hope you will choose to connect with us through all of these opportunities!



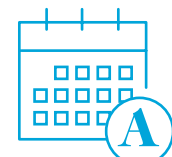
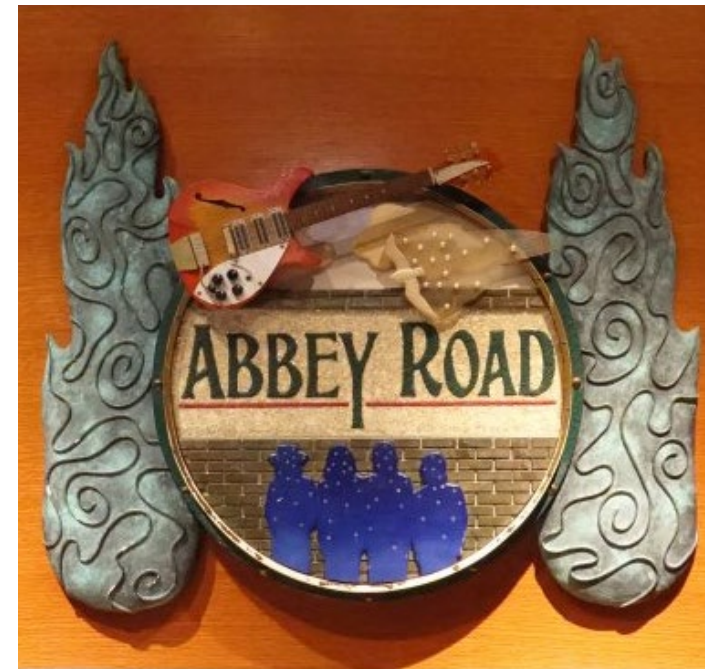

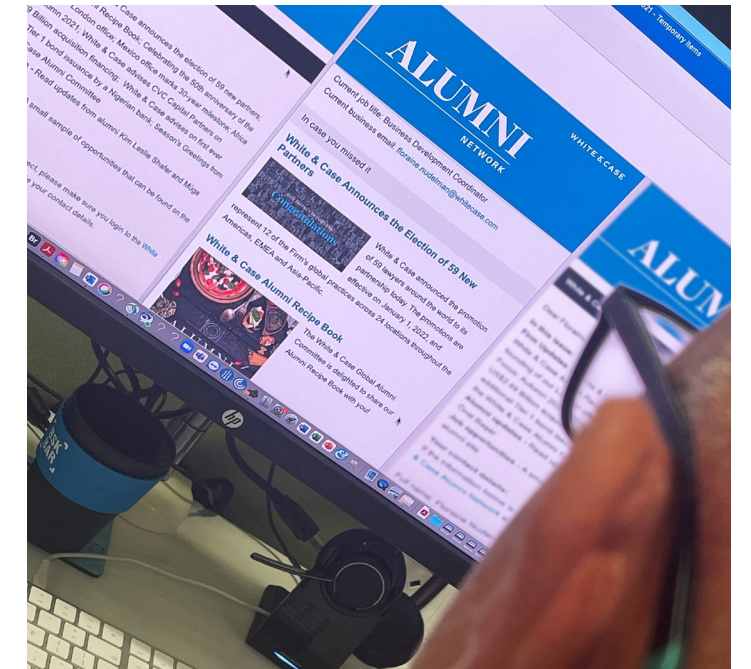
Website

alumni spotlight interviews. If as an alum you have any personal or professional news to share, you can post it directly onto the alumni site.

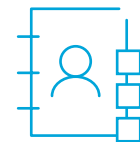

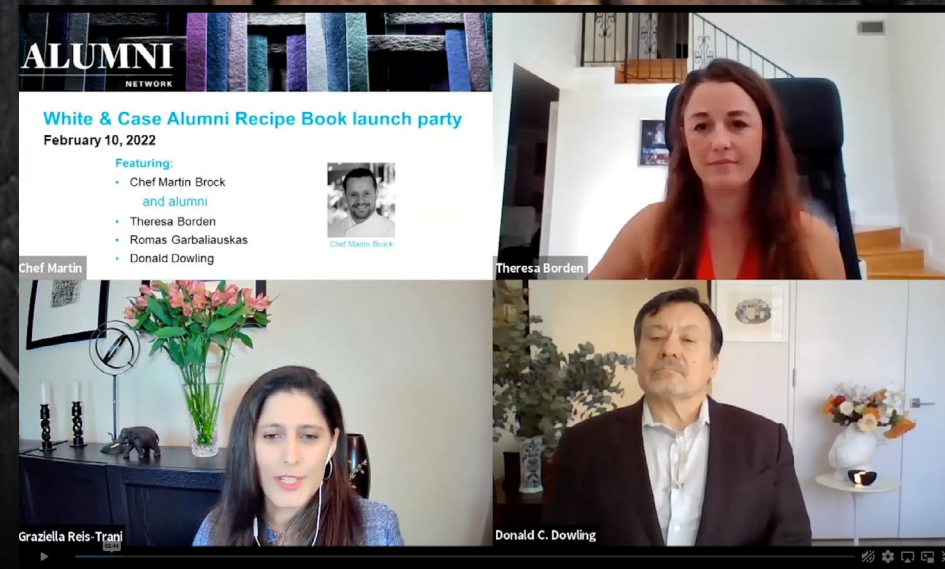

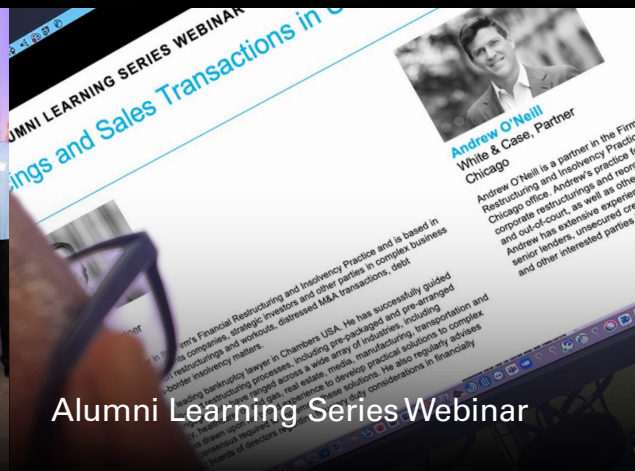

Events

Alumni

White & Case's Global Alumni Program organizes both in-person and virtual alumni events around the world.

To give you a sense of the scope of our Alumni Program, we have hosted alumni events in places such as Buenos Aires, Frankfurt, Hamburg, Hong Kong, Istanbul, Lima, London, **Mexico City**, Miami, Moscow, New York, **Paris**, Prague, Santiago, São Paulo, Singapore, Stockholm, **Tokyo** and Washington, DC.

These events have included office-wide alumni receptions; educational programming; practice, region or industry-specific events; and class reunions, to name a few. In addition to the in-person alumni events, we have also conducted social and cultural virtual alumni events as well as educational events. Our social and cultural events have included a concert with TONY-nominated Broadway singer

Eva Noblezada, a series with curators from the Tate Modern, a Holocaust remembrance event with alum Owen Pell, a discussion with alum Mark Levine on the trial of the Chicago 7 and a launch party to the *White & Case Alumni Recipe Book* to name a few.
